 - i) All general meetings are open. Special EC meetings are not.

- q) Required votes for approval (Article 7d)
 - i) Simple majority of NJLMSC board required for approval of vote.
- 2) Clarification of GSM for NJLMSC membership
 - a) Should GSM continue to exist as a club? Yes.
 - b) Darek Hahn moved that the GSM contact name (for registration of club with USMS) will be a volunteer from the GSM membership. MSA
 - c) Should GSM be the default club for NJLMSC swimmers? No. Default will be "unattached." Registration form will provide explanation of all club options and implications. Each club's information to be provided by each club's contact person. Club information should be factual and brief, and not of a "marketing and advertising" nature. This information is due to Tom Brunson by October 30, 2005.
 - d) Ed Tsuzuki moved that the GSM finances be handled outside of the NJLMSC funds. i.e. GSM club fee (of \$50) will be paid by GSM to NJLMSC. 4 in favor, 2 opposed MSA
- 3) Relay fee
 - a) Darek Hahn has suggested that the relay policy (NJLMSC will reimburse for any club's relay entries USMS and FINA zone, national, or world championship meets) be more widely publicized to the entire NJLMSC membership.
- 4) Individual Registration Fee
 - a) Ed Tsuzuki moved that the registration form be changed to indicate that the membership fee be stated as \$26 and that an additional line for receipt of hard copy of the newsletter at \$17 (increase of \$1) be added. MSA
- 5) Club Registration Procedure
 - a) Link to USMS club registration form should be provided on the website (page 13 of http://www.usms.org/admin/lmschb/lmsc hb reg.pdf)
- 6) Membership Promotion
 - a) Registrar will add a line to registration form for referrals.
 - b) Chairperson to provide communication announcing membership campaign.
 - c) Webmaster posts new membership form to website.
 - d) Secretary distributes e-mail to NJLMSC membership to print form and register.
 - e) Membership promotion campaign kicks off on November 1, 2005.
 - f) Registrar will begin tracking new registrations.
 - g) There will be three periods (11/1/05 to 3/31/06, 4/1/06 to 6/30/06, and 7/1/06 to 10/31/06)
 - h) Only current members will be eligible for referral credit and awards.
 - Awards will be given 1 week after period closes and will be announced as follows:
 - i) e-mail note
 - ii) Web site posting
 - iii) Fast Lane Newsletter
 - j) Award will be a \$2 discount off 2007 membership fee (for each new swimmer brought in) or a gift certificate for that total amount (swimmer to decide).
