USMS Long Distance All American Jeff Jotz and other experienced open water swimmers will prepare you for swimming in everything from a backyard pond to the English Channel. Clinic will consist of dryland instruction as well as swimming in the shallow, calm waters of Lake Hopatcong. **Beginners and advanced open water swimmers are welcome, but all swimmers should be able to complete an 800-yard pool swim without difficulty before participating in this clinic.** Refreshments will be provided for participants.

Wetsuits are allowed but not necessary, as the lake is quite warm.

ENTRIES: The clinic is open to all Masters Swimmers holding a valid 2011 USMS registration card. A copy of your card must accompany your entry! Non-USMS members can register for a one-day USMS membership for an additional \$15, payable to NJLMSC (form attached).

COST: **Pre-registration required.** \$40, postmarked by July 25.
Clinic size is limited to 15 swimmers.

DIRECTIONS: I-80 east/west. Exit at 34 or 34B (Route 15 North). Follow Rt 15 for 5 miles and exit at Rt 181 North (Lake Forest, Woodport, Lk Hopatcong North Shore). Follow Rt 181 North past Oh Sullivan's Pub on left, Hopatcong boathouse on right, cross water, marina on left, Warehouse Grill on left, Boat Doctor on left, **TAKE NEXT RIGHT ONTO LORETTACONG DR.** House is the 3rd one on the right - two story wood look siding with stone accents.
